Narrative:

On November 23, 1990, a call was received at 06:36 from Ms. Amy Roebse reporting her daughter, Laura Roebse, missing. Officer Marous arrived Ms. Roebse's residence at 06:58 to conduct a search along with fellow Officers Caden and Malaru. Officers investigated all rooms in the house and found various belongings missing from Laura's room including clothes, snow boots, a blanket, various stuffed animals, and a drawing pad. The window in Laura's room was slightly open and Ms. Roebse acknowledges the window was closed when tucking her daughter into bed last night. Officers conducted a search in the woods near the residence and had found two sets of footprints. Officers estimate the first set belongs to a child while the other belongs to an adult based on differences in size.

Ms. Roebse summarized the events of the previous night: Laura had been watching TV in the living room from 18:30 to 20:00. Ms. Roebse shut the TV off at this time and described a verbal altercation. When Ms. Roebse shut off the TV, Laura had appeared enraged and demanded the TV be turned back on. Ms. Roebse states Laura wanting to watch TV past bedtime was common, but the anger was new. Ms. Roebse tried to calm Laura down, but Laura was insistent that she needed to watch the end of the episode. Ms. Roebse claims that Laura had saw her name at the end of an episode and needed to see what happened. On Laura's insistence, Ms. Roebse turned the TV back on, but the program Laura had been watching had already ended and moved onto another show. Ms. Roebse concludes that Laura was just using an excuse to keep watching TV and eventually got Laura ready for bed. Ms. Roebse says Laura was adamant at first, but eventually gave in. Ms. Roebse tucked Laura into bed by 20:30 and she herself was in bed by 22:45.

Ms. Roebse woke up at 6:15 this morning and went into Laura's room at 6:30 to get her ready for school. Upon not finding her daughter, Ms. Roebse searched the rooms of the house and when she had not found her daughter, she called police.

When asked about noises in the night, Ms. Roebse recalls not hearing anything. Ms. Roebse suspects her ex-husband, Mr. Alan Palerna, of being involved. Both Ms. Roebse and Mr. Palerna will be brought to the station for further questioning.

Ms. Roebse recalls Laura's anxiety has increased since the Ms. Roebse filed for divorce against Mr. Palerna on November 5, 1990. Ms. Roebse claimed Mr. Palerna had assaulted Laura, leading to her broken elbow. Ms. Roebse provided the information of their current social worker Dr. Kelly Terance. When asked about any other doctors, Ms. Roebse provided information on Laura's former therapist Dr. Valteri Nadear, noting that Laura was much closer to Dr. Nadear than Dr. Terance.

Police have been called to the residency in the past due to alleged physical abuse by Mr. Palerna. Charges are still pending.
